C.S.A. § 2501 et seq. and any amendments thereto; (f) exhibitor authorizes Farm Show management, or its designee, to use, reproduce and/or publish photographs and/or video including exhibitor's image, likeness and/or voice without compensation in order to promote or publicize its activities; (g) the information on exhibitor's entry form may be shared with the members of the Pennsylvania General Assembly representing exhibitor's place of residence; (h) exhibitor intends to be legally bound by the above language by signing their name and by entering the animal(s) and/or participating in the show. By signing, exhibitor verifies that exhibitor has read, understands, consents to and agrees to abide by terms and conditions stated herein, in the premium list and in all show rules. Exhibitor makes all statements contained in this entry form subject to the penalties of 18 PA.C.S.A. §4904 (relating to unsworn falsification to authorities). If the animal owner is under 18 years of age, the signature of a parent/guardian is required in addition to the signature of the minor.

- Please do not enter Junior Market Animals on this form. See your FFA Educator or 4-H Agent/Leader.
- Use owner's full Name, Address & Social Security Number. Include date of birth if a junior exhibitor. Must have FFA Chapter or 4-H Club and County.
- Check the Dairy Herd Unit entry type. The major exhibitor must list all Dairy Herd Unit members.
- Use correct class number for Open, Junior, & Group
- Individual animal entries:
 - Print Specie
 - Print breed.
 - Include exhibit name
- Individual animal entries continued:
 - List Registration, Ear Tag, Tattoo, DOB, Circle Female or Male, Circle Beef Cow or Calf, Father and Mother's name of animal, Beef Calf information for cow/calf class.
 - Include the Breeder of the animal from the registration papers.
 - List the entry fee. **No entry fees for junior or group classes.**
- Group Class Entries:
 - Use correct class number for Group or Hitch classes.
 - Print the class name on animal name line.
 - Get-of-Sire - identify the Sire
 - Produce of Dam - identify the Dam
- Total the entry and other fees. These must equal the total amount enclosed. (Total of all pages of animals & classes)
Dairy & Beef Cattle: \$20.00 each
Alpaca: \$8.00 each
Swine, Sheep & Dairy/Boer Goats: \$10.00 each
- The owner or legal agent must sign and date each form. Include the telephone number of the person to contact if clarification is needed.
- Checks made payable to Commonwealth of Pennsylvania.
- Entry Cancellations on or before December 23 will cause forfeiture of entry fees without penalty. A \$100 penalty per animal will be assessed to the owner of each horse, dairy, or beef animal entered but not exhibited at the Farm Show.**
