C.S.A. § 2501 et seq. and any amendments thereto; (f) exhibitor authorizes Farm Show management, or its designee, to use, reproduce and/or publish photographs and/or video including exhibitor's image, likeness and/or voice without compensation in order to promote or publicize its activities; (g) the information on exhibitor's entry form may be shared with the members of the Pennsylvania General Assembly representing exhibitor's place of residence; (h) exhibitor intends to be legally bound by the above language by signing their name and by entering the animal(s) and/or participating in the show. By signing, exhibitor verifies that exhibitor has read, understands, consents to and agrees to abide by terms and conditions stated herein, in the premium list and in all show rules. Exhibitor makes all statements contained in this entry form subject to the penalties of 18 Pa.C.S.A. §4904 (relating to unsworn falsification to authorities). If the animal owner is under 18 years of age, the signature of a parent/guardian is required in addition to the signature of the minor.
